2024 Annual Fire Safety Report

Fire Statistics for 2021-2023



Cal Poly maintains a comprehensive fire safety program involving response, testing, drills, procedures, and inspection. The campus contracts with the San Luis Obispo City Fire Department for fire suppression response in the Local Response Area of campus. The California Department of Forestry and Fire Protection (Cal Fire) responds to the State Response Area of campus, including the outlying agricultural facilities and surrounding lands. Both agencies participate in mutual aid agreements to ensure complete and timely responses to any fires on or near the campus property.

Fire Safety Policies in On Campus Residence Halls

All Resident Advisors and the live-in professional Coordinator of Student Development positions must attend annual training on evacuation processes and meeting locations, fire safety, fire prevention, fire extinguisher use, and building evacuation essentials. This training consists of approximately one hour of classroom instruction. These positions participate in and lead the annual resident building evacuation drills. Fire Safety training is provided to housing residents/students (non-staff) through the fire drill process.

As part of its fire safety and prevention efforts, the University has implemented the following policies in campus housing facilities (disseminated via an online *Policy guide and Title 5* found at <http://www.housing.calpoly.edu/content/university-housing-policies>:

Appliances and Electronic Devices

Appliances such as clocks, lamps, hair-dryers, computers, stereos, televisions, and the like are permitted in student rooms and public areas of the facilities, provided the resident ensures the following:

- Appliances are UL-approved
- The wiring of appliances is safe and plugged into an electrical outlet utilizing a surge protector
- Appliances are turned off when not in use
- Requests from other residents or staff regarding noise from appliances are respected

4.1 Use of items such as air fryers, electric fry pans, coffee pots, toasters, toaster ovens, rice cookers, and blenders cannot be plugged in or used in student rooms. They are only permitted in the kitchen area of the residence halls, apartments, and suites.

Fire Safety

Residents are encouraged to decorate their rooms. However, for the safety of our community, some items are not allowed in student rooms or apartments. A complete list of things to bring and leave behind can be found [here](#). Staff will announce themselves and enter apartments and residence hall rooms to complete mandatory fire and life safety checks periodically during the year. To prevent fire and protect the safety of our community, please be mindful of the following regulations:

11.1 Use or possession of items with a heating element in student rooms or apartments, including, but not limited to, barbecues, electric grills, hot plates (permitted in apartment kitchens), and space heaters, is not permitted.

11.2 Highly flammable materials in student rooms or apartments — including, but not limited to, gasoline, industrial cleaning solvents (e.g., benzene, kerosene, trichloroethylene), spray paint, charcoal, lighter fluid, vehicle parts, fuel, and oil — is not permitted.

11.3 Possession of candles, incense, or other flame-producing materials is prohibited.

11.4 Room occupancy is limited to six persons per residence hall room or twelve persons per apartment (Cerro Vista and Poly Canyon Village). Occupancy may be adjusted based on occupancy needs and public health mandates.

11.5 Blocking of any door or emergency exits, including window access, is a fire hazard and is not permitted.

11.6 Tampering with, discharging, or damaging a fire extinguisher is prohibited when no fire is present.

11.7 Residents may not block access to a fire extinguisher.

11.8 Tampering with or damaging fire life safety equipment — including but not limited to, sprinkler systems, fire alarms, exit signs, etc. — is prohibited. This includes hanging items from life safety equipment such as pipes, sprinkler heads, pull stations, etc.

11.9 Tampering with or jumping in elevators is prohibited.

11.10 Residents are not permitted to possess or use items that create a fire hazard, including permitted items in excessive quantities.

11.11 Residents who may require special assistance in emergency evacuation situations should contact the [Disability Resource Center](#) before move-in or as soon as possible to plan for the event of an emergency. Do not wait for a crisis to occur.

20.1 Per Executive Order 1108, Cal Poly is a smoke and tobacco-free campus. Smoking and tobacco are not allowed on campus in any form, including vaping, chewing, etc.

Emergency Preparedness

Our residence halls and apartment buildings are equipped with fire safety equipment, including fire alarms. When a fire alarm sounds, residents will need to evacuate the building. Residents can find information about their evacuation point on the back of their room/apartment door and in Appendix A of this report. Residents who may require special assistance in emergency evacuation situations should contact Cal Poly's [Disability Resource Center](#) before move-in or as soon as possible to plan for the event of an emergency.

Fire Drills are conducted yearly in each University Housing Community. Residents are expected to evacuate the building and proceed to their designated evacuation areas for attendance and further staff instruction. Failure to evacuate correctly will result in community standards action.

The Cal Poly Police Department and the Fire Department will automatically be notified when your smoke detector goes off in on-campus housing. If you set off your smoke detector/fire alarm and there is no fire, please contact the Cal Poly Police Department at (805) 756-2281 and let them know. They will still send an officer to verify your safety and turn off the alarm.

All fires, no matter how small, are to be reported to Cal Poly Police at 911 or 805-756-2281. If the fire is extinguished, notify Cal Poly Police at 805-756-2281.

Planned Future Improvements

There are no planned future improvements to fire safety in on campus residence halls at this time.

Fire Safety Policies in On Campus Agricultural Operations Living Quarters

SMOKING AND TOBACCO POLICY

Effective September 1, 2017, all California State University campuses shall be 100% Smoke Free and Tobacco Free. Smoking, the use or sale of tobacco products, and the use of designated smoking areas are prohibited on all California State University properties. Members of the CSU community are expected to fully comply with the policy. Any sponsorship and/or advertising in respect to any university activity or event by a tobacco product manufacturer is prohibited unless explicitly authorized by the University President or designee.

ELECTRONIC APPLIANCES POLICY

Allowed electronic devices include but are not limited to: Computers and related devices, cell phones, tablets, gaming consoles, GPS devices, clock radios, and televisions. Stereos and fish tanks, where approved, must be plugged into an electrical outlet utilizing a surge protector and their electrical cords must be in good repair.

Electronic cooking devices, including rice cookers, toasters, blenders, indoor grilling machines, etc., may only be used in the kitchen areas. Appliances must be directly supervised at all times while in use.

Refrigerators must be kept in an open space that allows ventilation. Refrigerators may not be placed in room closets or underneath desks. They must be plugged directly into a wall socket.

OPEN FLAME POLICY

State fire code prohibits the use of any open flames including, but not limited to: Candles (lit or unlit), incense, and “sterno” devices. Lighting or attempting to light any material/substance on fire, as well as the use of matches or lighters within agricultural student housing, is strictly prohibited. Battery operated candles may be utilized in rooms.

PROCEDURES IN CASE OF FIRE

Evacuation

In case of fire, all residents must exit the building and get at least 50 feet away. Call 911 and wait for the fire department to arrive.

Report

All fires in Agriculture Operations Living Quarters must be reported immediately to Cal Poly Police via 911.

016A - Herdsman Hall, 018L Dairy Science, and 055M – Beef Cattle Evaluation Center Residence Modular have monitored fire alarms. Cal Poly Police Department and the Fire Department will automatically be notified when your smoke detector goes off. If you set off your alarm and there is no fire, please contact the University Police Department at (805) 756-2281. They will send an officer to verify your safety and turn off the alarm.

FIRE SAFETY EDUCATION AND TRAINING PROGRAMS POLICY

Fire safety training is not currently required for Agriculture Operation Living Quarters residents. The University plans to implement annual training on fire safety, fire prevention, and fire extinguisher use beginning in 2025.

PLANNED FUTURE IMPROVEMENTS

Annual fire safety training for Agriculture Operation Living Quarters residents is scheduled to be implemented in 2025. Evacuation diagrams are scheduled to be posted in 2025.

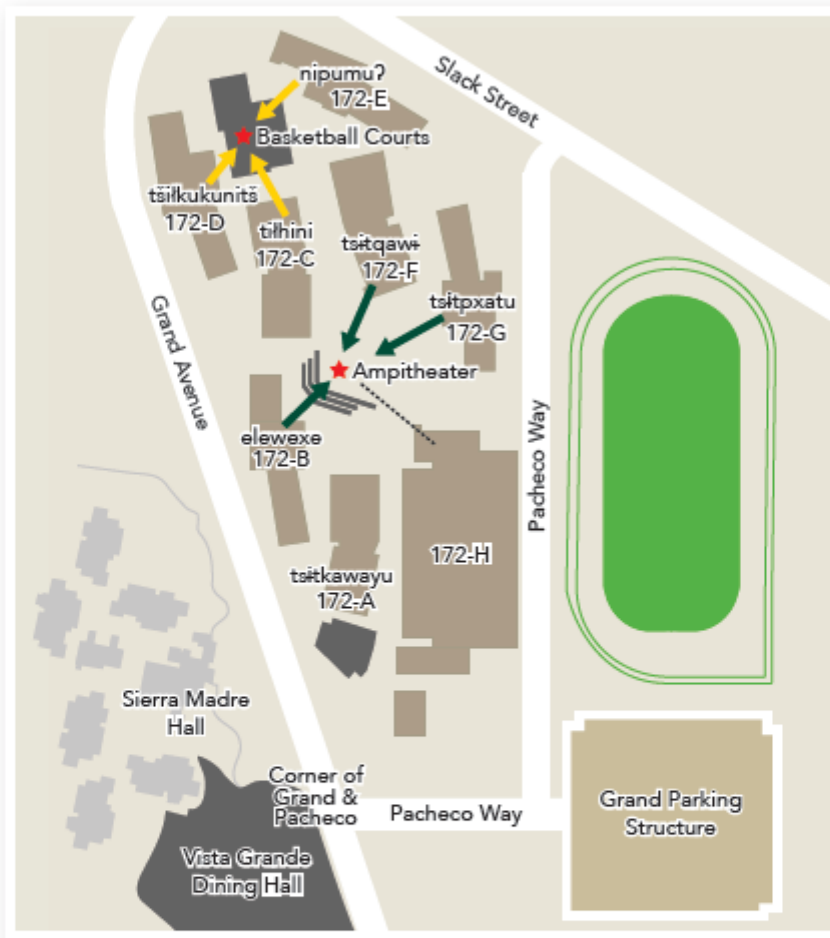

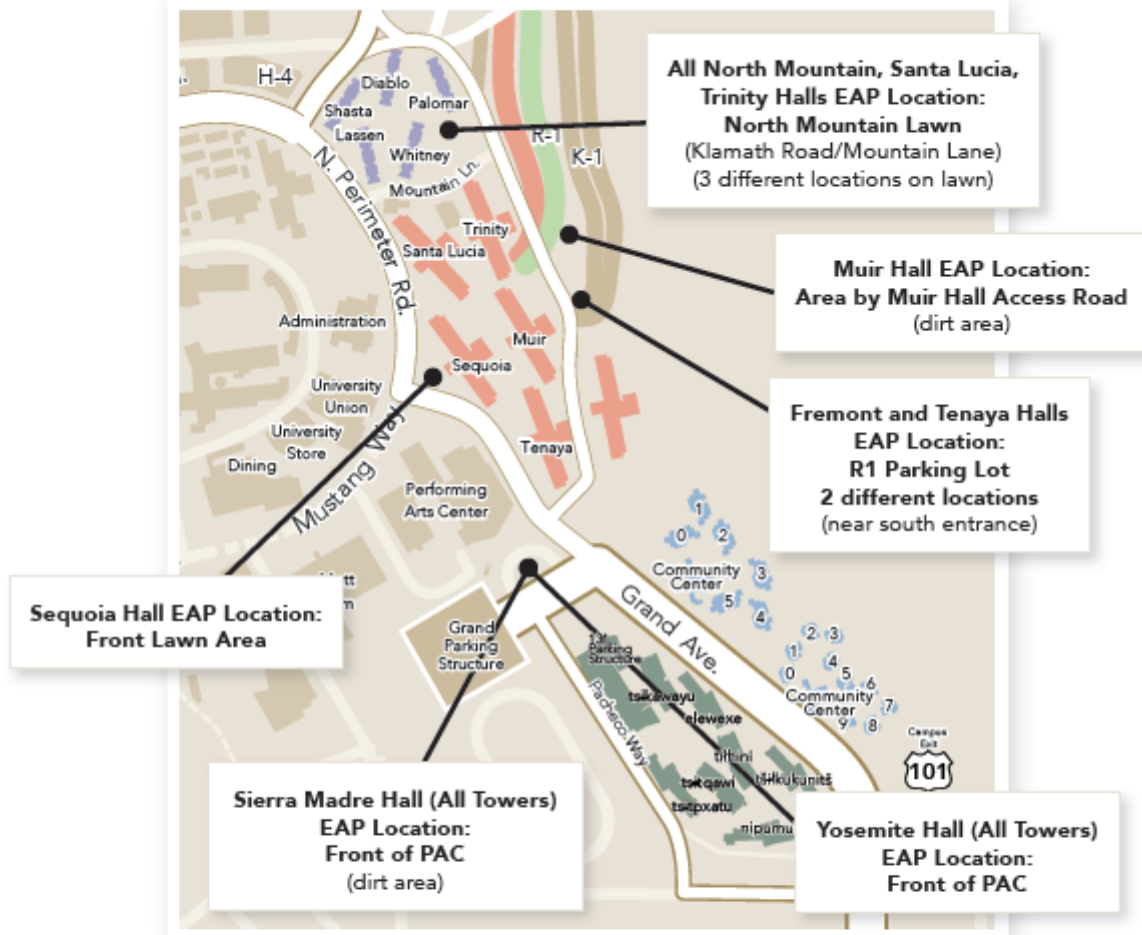
