## REQUEST FOR QUALIFICATIONS ARCHITECTURAL SERVICES FOR PROGRAMMING & FEASIBILITY STUDY OF THE COLLEGE OF AGRICULTURE, FOOD AND ENVIRONMENTAL SCIENCES PLANT SCIENCES COMPLEX RFQ MAJ 16-MJ0071.P

California Polytechnic State University, San Luis Obispo (University), a campus of the California State University (CSU) system, is proposing to retain the services of firms with verifiable experience designing agricultural facilities who meet all requirements of this RFQ, to assist the University in programming of the College of Agriculture, Food and Environmental Sciences Plant Sciences Complex. The selected Respondent will enter into a professional services agreement with the University.

The project will be comprised of energy efficient and sustainable design features balanced with the program needs within the available budget. The architect will program the project so it is capable of achieving a standard equivalent to LEED Gold and will meet the CSU Sustainability Measurement System guidelines.

In addition to programming, the Service Provider will provide a conceptual construction estimate and assist with the submission of a Capital Outlay Budget Change Proposal (COBCP) to the California State University Chancellor's Office.

Respondent firm experience shall include programming of plant science facilities and completed at least two (2) programs for plant science facilities within the last ten (10) years; completed the design of at least one (1) plant science facility within the last five (5) years; and completed the design of at least two (2) other facilities with a construction cost of at least (\$10,000,000) per project within the last ten (10) years. Primary Contact Professional experience shall include programming of greenhouse facilities and completed at least two (2) programs within the last ten (10) years; and completed at least one (1) new greenhouse or plant science facility with a construction cost of at least (\$5,000,000). All requirements are included in the RFQ.
