Call to Order

Co-Chair Andrews called the meeting to order at 11:11 a.m.

Review/Approve Meeting Record

Motion to approve the 4/9/24 meeting record by Dr. Jackson-Elmoore, seconded by Co-Chair Kraetsch. Motion passed by unanimous voice vote.

Discussion and Voting

In the previous meeting, Co-chair Andrews sought information regarding the projected number of students that the funds were expected to serve through the proposals. Today Ms. Windokun responded that the \$1,000,000 in financial aid would be awarded to 238 students. The \$2,000,0000 for General Education Courses will help cover 22,961 seats, 493 sections, 44 FTE lecturers in General Education areas A, B, C and F.

Mr. Kartha sought clarification on the future funding plan for lecturers, given that the current allocation is only one-time funding. Dr. Jackson-Elmoore explained that these are unmet needs that come and go, and where the need is can move from year to year. She further clarified that they are being responsive to exactly what students need, and lecturers are hired on shorter contracts to allow them to manage through.
