#### Call to Order/Introductions

Co-Chair Spragins called the meeting to order at 9:14 a.m.

#### Review/Approve Meeting Record

The committee members reviewed the 5/15/25 meeting record, and with no objections, the record was approved.

#### **Base Funding Request Discussion**

Co-chair Valadez reviewed the CPOF Budget Summary for FY2025/26 and the two proposals to be moved forward. The first proposal was the contingency funding for the compensation adjustment for FY 25/26 Direct Student Support and Advising. The budget would be \$6,381,750, which includes the contingency for compensation adjustments. The second proposal would be to utilize \$247,964 of the unallocated base (\$809,439) to permanently fund expenses that have been one-time funded the past two years. The remaining \$561,475 of unallocated base would be held in budgeted reserves and revisited in early fall when the committee reconvenes and final state budget decisions have been made.

#### Voting

Dr. Isom made a motion to approve the 2025/26 Cal Poly Opportunity Fee Budget; seconded by Mr. Shea. The allocations were approved by unanimous vote.

There being no further business, the meeting was adjourned at 9:19 a.m.
